(the “**Ski Club**”) allowing me, the undersigned, to participate in any Ski Club sponsored event, including, but not limited to, any tournaments, clinics, shows, exhibitions, races, competitions, practices, free skiing (or other water sports activities undertaken behind a boat), social gatherings, and related activities, both on and off the water, whether sanctioned by USA Water Ski or otherwise (the “**Event**” or “**Events**”); I, for myself, and on behalf of my spouse, children, guardians, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors and assigns, hereby agree to and make the following contractual representations pursuant to this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement (the “**Agreement**”):

1. I hereby represent that (i) I am at least eighteen (18) years of age or older; (ii) I am in good health and in proper physical condition to participate in the Event; and (iii) I am not under the influence of alcohol or any illicit or prescription drugs which would in any way impair my ability to safely participate in the Event. I agree that it is my sole responsibility to determine whether I am sufficiently fit and healthy enough to participate in the Event, that I am responsible for my own safety and well being at all times and under all circumstances while at the Event site.
2. I understand and acknowledge the risks and dangers associated with participation in the sport of water skiing, related water sport disciplines, and related activities on the water, including without limitation, the potential for serious bodily injury, sickness and disease, permanent disability, paralysis and loss of life; loss of or damage to equipment/property; exposure to extreme conditions and circumstances; contact with other participants, spectators, boats, animals or other natural or manmade objects; dangers arising from adverse weather conditions; imperfect ski course conditions; water and surface hazards; equipment failure; inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the Event Organizers; and other undefined, not readily foreseeable and presently unknown risks and dangers (“**Risks**”). ## **New Member Information sheet (Q & A)**

### **When / Where are the meetings?**

The meetings are on the 3<sup>rd</sup> Tuesday of each month at 7:30 at Anne's Mexican Grill.

Anne's Mexican Grill is located at 1009 Cheek-Sparger Rd., Colleyville, TX 76034. There is not a meeting in December. It is optional to attend, but highly recommended.

### **I am not very good at skiing, will I fit in?**

The best part of our club is that we have a variety of skiers with different skills and different levels of expertise. There is a place for everyone, and most members enjoy teaching people how to do new things. We offer a Slalom 101 course and a Ski League for coaching and friendly team competition.

### **Where can I ski?**

We have 2 sites available with your membership.

1. [Marine Creek Lake](#) which is located off of 820 West and Marine Creek Parkway in Fort Worth. The entrance is the top gate on the right, at the top of the big hill halfway between Marine Creek Parkway and Azle Ave.
2. The Trinity River site is located in the Downtown Fort Worth area off of Henderson St. (199). The entrance is the left gate outside the Golden Gloves parking lot at [1040 N Henderson St, Fort Worth, TX 76107](#)

You will receive the gate code for each site once a full member.

### **I don't have a boat; can I still join?**

Absolutely! Once you come to a meeting and the lake, you will meet people and boat owners who are more than willing to pull, teach, and set times to meet at the lake. An officer or other club member can help you network. In general, skiers pitch in anywhere from \$5-\$20 per set on the water towards the boat driver. It varies per driver, and is fully at their discretion. It is advised to find out before skiing.

### **How can I keep informed with what's going on?**

Emails are sent out and reading them is a great way. In addition, follow the club on [Facebook](#) and [Instagram](#). If you are not receiving emails, please contact the secretary to verify your email address.

\*If emails are not checked and opened, the email system, will drop you from receiving.\*

### **Do you host tournaments?**

Yes! We host at least one tournament a year in June or July. It is usually a Class C slalom and Grassroots 3-event. The tournament is at a very reasonable fee, and many club members participate. It is possible we will also be the host location for various pro tour stops as we have in the past.



# Metroplex Ski Club Rules of Engagement (Rev Jan/2019)

The following is a synopsis of rules as defined in our operating code for members to observe when using Metroplex Ski Club (MSC) sites:

**General:** Our ski sites are under the control of the State of Texas and are managed and patrolled by the Tarrant Regional Water District (TRWD). All members must adhere to the [Texas Water Safety Act](#) as well as all laws governing public use of state controlled waterways.

MSC is a family oriented ski club that desires to project a positive image within the community and maintain a safe environment for our members and guests. For this reason, and our own safety, members and guests are to refrain from consuming any alcohol at our sites until which time that they have stopped participating in on-water activities including but not limited to: boat driving, riding as a passenger, or skiing.

MSC members and guests shall not use or possess any unprescribed or illegal drugs at any time. MSC members of legal age may consume alcohol, within reason and as allowed above, and by local ordinance and state law. Violation of this rule may result in revocation of membership.

**USA Waterski (USAWS) "Active" Membership Requirements:** All persons, whether club members or guests, who participate in club activities MUST have current [USAWS "active" membership status](#). Participation includes skiing, driving or riding in a boat and any activities on the ski dock. This is mandatory in order for our liability and medical insurance coverage to be in effect, which is a requirement of our ski site lease agreement with TRWD. If even one person at the site is not a current **USAWS** active member, our club insurance is not in effect which puts our continued use of the ski sites at risk as well as making MSC members personally liable for any damages which might occur.

**Guests:** Guests can ski at MSC sites on an occasional basis if they are current "active" members of **USAWS** and are accompanied by a MSC member. Guests that are not active USAWS members must be approved by a club official and complete a [temporary membership form](#) in order to use the site. Occasional basis is defined as no more than three uses within a single calendar year. If a guest frequently uses the MSC sites, the hosting MSC member should strongly encourage the guest to join.

**Skiing Order:** Skiing order is based upon boat rotation, as opposed to skier rotation. Boat rotation means that each boat takes a set and then relinquishes the site to the next boat waiting in line, regardless of the number of skiers in any given boat. After launching your boat and arriving at the ski dock, your set will precede the boat currently skiing, after all other boats waiting have completed a turn. If in doubt as to your position in line, ask. After your boat has pulled a set, take your place in line immediately after the boat you followed previously. If there are several boats waiting their turn, it is recommended that the next skier up have all their gear on and be ready to jump in the water as soon as the previous boat has finished their set.

**Slalom Course:** The slalom courses may be used at any time by members on a first come, first serve basis per the established skiing order. A set is defined as six passes. A single pass is defined as when a boat passes through the entrance gates. When the skier falls, the boat shall pull the skier in the same direction traveled previous to the fall.

**Jumping:** The jump may be used at any time by members on a first come, first serve basis per the established skiing order. Any member wishing to use the jump must have a full USAWS membership (Grassroots memberships are not allowed to use the jump), and must be certified by the Jump Certification Committee by demonstrating the following:

- Ability to safely ride over and complete three consecutive jumps.
- Proper procedure for setting up and leaving the jump.
- Correct boat driving skills for pulling a person over jump.
- Familiar with all rules as it applies to the use of jump.

When approved by the Jump Certification Committee, the member will be given the combination to the lock on the jump. Non-certified members may learn to jump if accompanied by a certified member.

All jumpers must wear a helmet, and Personal Flotation Device (PFD) such as a neoprene, nylon (or similar material) covered suit or vest specifically designed by a manufacturer for that purpose. All PFD's must be capable of floating the skier, be of non-inflatable design, and be fastened in such a manner that they are unlikely to be torn loose, so as to render them useless in a hard fall. They should be constructed so as to provide adequate protection from impact damage to the ribs and internal organs. A life belt shall not be used as a PFD.

All jumpers must use equipment which will not damage the jump. A member may take 4 consecutive passes at the jump and then must release his/her turn to the next member waiting to ski.

**Trick Skiing, Wake Boarding, Barefooting, etc:** The ski site may be used at any time by members on a first come first serve basis per the established skiing order. A member may take up to 10 minutes per set and then must release his/her turn to the next member waiting to ski.

MSC sites are designed to promote USA Waterski sanctioned disciplines. The use of the MSC sites for non-sanctioned disciplines should not interfere with sanctioned disciplines. All sanctioned and non-sanctioned activities should be performed by MSC members and/or guests that are USA Waterski members. Please be respectful of members who have limited time to practice their sport when considering non-sanctioned disciplines.

**Show Ski Practice:** The Marine Creek Site is reserved for show ski practice on Saturdays from 12 noon until 3:00 PM, from mid-May through September. Please refer to the [club calendar](#) for exact dates. All members are invited and encouraged to participate fully in show ski activities.

**Boat Driving Practices:** Launching and loading of boats should be accomplished between skier passes as to not interfere with skiing activities.

If a skier falls in the slalom course, maintain boat direction down course until the boat has come to idle speed and then turn around (at idle speed) to retrieve skier. This action will prevent boat rollers in the slalom course.

Be aware of potential floating debris at sites especially the Trinity River, particularly after a heavy rain. It is recommended to drive the length of the ski site looking for any floating debris before skiing.

No boats or skiers are allowed beyond the railroad bridge on the east side of the Henderson Street Trinity River Site.

~~No boats or skiers are allowed beyond the railroad bridge on the west side of the 4<sup>th</sup> Street Trinity River Site slalom course.~~ At this time no boats or skiers are allowed at the 4<sup>th</sup> street Trinity River Site. Disregarding these rules will lead to the loss of use of these sites.

No skiing is allowed outside the floating marker signs at the Marine Creek site. The rest of the lake is a "No-Wake-Lake".

**Speed Control Devices:** Only USAWS approved speed control devices should be installed and utilized on member boats used on our sites. This will prevent the potential for accidents and malfunctions which could lead to insurance claim denials under the USAWS umbrella policy. Please contact USAWS for a list of current and past approved speed control devices if there are any questions regarding your specific speed control application.

**Site Practices:** When accessing any of the MSC sites use extreme caution when crossing paved trails. At no time shall a member park a vehicle on the trail, and should refrain from driving on trails when possible. Be aware and courteous to all trails users and yield the right away at all times.
